


Valent BioSciences, LLC announced a major expansion of its biorational manufacturing facility in Osage, lowa, which will meet increasing demand for its biorational products. The expansion project includes a new pilot plant facility with state-of-the-art development equipment, and, in collaboration with Heartland Power Cooperative, a 1.5 megawatt solar facility to provide the manufacturing plant with renewable energy.

The innovative facility was designed with the goal to provide muchneeded daycare for as many as 220 children. Financing Terms

Amount

 Determined on a case-by-case basis by the cooperative board of directors; based on the project and specific loan program requirements

Rate

- Typically ranging from 0% to below prime interest rate
- Determined on a case-by-case basis by the cooperative board of directors

Term

• Maximum of 10 years

Security

 Adequate security as determined by the cooperative board of directors
